The following information is provided for your election to participate in ESD 112 clock hour services for 2010-2011. Districts have two options for participating in the clock hour process:

- **OPTION A** is a district paid option based on \$12.00 per certificated staff member.
- **OPTION B** provides clock hour class approval for a minimal charge of \$25 per application to the district. With Option B, employees are responsible for paying the ESD for registering clock hours.

**Clock Hour Background**

Certificated staff members that were issued continuing certificates after August 31, 1987, are required to document participation in 150 clock hours of college/university credit or approved clock hour credit every five years to maintain a valid certificate.

Since 1987, Educational Service District 112 has coordinated a centralized inservice approval and record keeping system. This provides districts with approval of clock hour courses and a transcript system for clock hours taken by certificated personnel for the purpose of advancement on the district salary schedule. All clock hours submitted to ESD 112 by certificated staff are recorded on individualized transcripts that are provided to the district on an annual basis. The system also simplifies record keeping for certificated staff maintaining clock hours for certification purposes.

**OPTION A  
District Pays Clock Hour Fee**

The school district pays an annual fee of \$12.00 per contracted certificated staff. Calculation of the fee is based on the 2009-2010 state personnel report (S-275).

The fee also covers the following:

- Application approval process
- Forms/printing
- All state required record keeping for approved classes. Provided to district personnel office prior to October 1 (with a copy for the employee).

**OPTION B  
Individual Participant Pays Clock Hour Fee**

Districts that choose not to participate in the district fee option (Option A) are able to access the services identified in Option A on a fee-for-service basis. The district pays an application fee of \$25.00 per class to access the clock hour approval process.

Certificated staff from districts that choose Option B will be required to pay a clock hour registration fee of \$2.00 per clock hour. All registered clock hours will be entered on a transcript that will be sent to the district personnel office of the certificated staff member.

## Educational Service District 112 Letter of Agreement

117. This agreement is made between ESD 112 and **Woodland School District** (hereinafter known as the District).

### Special Terms and Conditions

IT IS MUTUALLY AGREED THAT:

118. Educational Service District 112 will be identified as an approved clock hour provider for the District and will provide the following:

- A. Processing of completed applications for clock hour classes/workshops prior to their submission to the regional clock hour committee;
- B. Necessary forms and printing;
- C. All state-required record keeping for the participants and the District;
- D. An annual transcript for each certificated staff member to the participating district personnel office with a copy of the participants.

119. For the above services the District will pay a fee of \$12.00 per certificated staff member they employ. Billing will be based on the number of certificated staff listed in the 2009-2010 State Personnel Report (S-275).

120. The District will pay the amount of \$1,524.00, which is due and payable on October 1, 2010.
