## AGREEMENT FOR INTERDISTRICT COOPERATIVE EDUCATIONAL SERVICES FIRE SCIENCE PROGRAM 2010-2011 School Year

THIS AGREEMENT is hereby entered into by and between KELSO SCHOOL DISTRICT NO. 458, Cowlitz County, Washington, hereinafter referred to as the "serving district" and the following Washington State school districts, each hereinafter referred to as the "resident districts":

Longview School District No. 122, Cowlitz County Castle Rock School District No. 401, Cowlitz County Toutle Lake School District No. 130, Cowlitz County Woodland School District No. 404, Cowlitz County

The purposes of this agreement are to utilize an inter-district cooperative, as authorized by RCW 28A.225.25 in order to provide an educational program not otherwise available and to avoid duplication of specialized programs and facilities. The objectives for the Fire Science course is to provide an introductory fire science training class which will prepare students for careers in Fire Science and related fields. This course is linked to the Fire Science Program at Lower Columbia College and will be linked with Washington State University and will provide opportunities for continued education.

The cooperative will serve:

Longview School District 15 students Castle Rock School District 6 students Kalama School District 1 student Toutle Lake School District 4 students Woodland School District 4 students

Each student will be counted as a .4 for enrollment reporting through the Kelso School District. Transportation for the students is the individual responsibility of the student. Any student requiring specialized instruction to be successful in the Fire Science classroom will be the responsibility of the student's resident district. Kelso School District will be responsible for the attendance and grade reports for the Fire Science Class. All state required assessments will be the responsibility of the student's resident district. The costs to operate this cooperative program for the 2010-2011 school year will be funded from State or Federal sources.
