

2011 Legislative Session Guide

The 2011 Session began on January 10 and is scheduled to end on April 24.

It is the paramount duty of the state to make ample provision for the education of all children residing within its borders without distinction or preference on account of race, color, caste, or sex. (§ 1)

The legislature shall provide for a general and uniform system of public schools. (§ 2)

2011 LEGISLATIVE PLATFORM

All actions taken by the 2011 Washington State Legislature must be evaluated in light of the February 4, 2010, King County Superior Court school funding decision (*McCleary v. State*).

WASA will only support bills and budget items that address the following conclusions declared by Judge John Erlick in that decision:

- “State funding is not ample, it is not stable, and it is not dependable.”
- Paramount means “preeminent, supreme, and more important than all others.”
- “Without funding, reform legislation for basic education may be an empty promise.”

TELL YOUR STORY

As the 62nd Washington State Legislature writes the 2011–13 biennial budget, it faces a \$5 billion deficit. K–12 education funding was cut by over \$2 billion in the 2009–11 budget—including a \$300+ million reduction adopted in a December Special Session, with further potential cuts to come in the 2011 supplemental budget. There is every reason to believe K–12 will be hit with another round of drastic cuts this session. As an example, Gov. Gregoire proposed another \$2 billion in education funding cuts in her 2011–13 budget request.

The state’s daunting fiscal challenges are understood; tough decisions will have to be made by legislators and K–12 education is sure to be impacted. Sacrifices will have to be made, but we must ensure we sacrifice for our children and their education, not sacrifice our children and their future.

As the Legislative Session begins and further potentially harsh reductions to K–12 education are discussed, it is incumbent on school administrators to communicate with legislators. Be alert and be active in the legislative process. Use this 2011 Legislative Session Guide to engage with your legislators. Remind them that K–12 education is not simply just an expense—public education is a wise and sound investment in our future.

Remind legislators that they swore an oath to “uphold the Constitution and the laws of the State of Washington” and Washington State’s duty to education is constitutionally declared to be its paramount duty. Said plainly, funding K–12 education is the state’s first and highest priority before any other state programs or operations.

The reasons to provide an ample education to our children go well beyond a simple legal obligation. An educated citizenry is critical to the state’s democracy. In fact, a well-educated population is the foundation of our democracy, our economy, and the American dream. Public education plays a critical role in promoting equality, operating as the great equalizer and providing unprivileged citizens with the tools they need to compete on a level playing field with citizens born into wealth or privilege. Education also plays a critical role in building and maintaining a strong economy. Public education builds the well-educated workforce necessary to attract more stable and higher wage jobs to the state’s economy.

Again, public education is a wise investment in the future. It is up to you to ensure legislators and members of your local community remember that.

March 7, 2011	Last day to consider bills in house of origin (5 p.m.).
March 25, 2011	Last day to read in committee reports from opposite house, except House fiscal committees and Senate Ways & Means and Transportation committees.
April 1, 2011	Last day to read in opposite house committee reports from House fiscal committees and Senate Ways & Means and Transportation committees.
April 12, 2011 *	Last day to consider opposite house bills (5 p.m.) (except initiatives and alternatives to initiatives, budgets and matters necessary to implement budgets, differences between the houses, and matters incident to the interim and closing of the session).
April 24, 2011	Last day allowed for regular session under state constitution.
