NONDISCRIMINATION

The District, in accordance with state and federal law, shall provide equal educational opportunity and treatment for all students in all aspects of the academic and activities program without regard todiscrimination based on race, religion, creed, color, national origin, <u>age</u>, <u>honorably-discharged veteran or military status</u>, sex, sexual orientation <u>including</u>, gender expressions or identity, <u>marital status</u> the presence of any sensory, mental or physical disability, or the use of a trained dog guide or service animal by a person with a disability. <u>The district will</u> provide equal access to school facilities to the Boy Scouts of America and all other designated youth groups listed in Title 36 of the United States Code as a patriotic society. District programs shall be free from sexual harassment.

As required by law to ensure that there is equal opportunity for all students, the district will provide continuous notice of nondiscrimination, and will provide annual notice of the district's discrimination complaint procedures to students, parents and employees. The district will also conduct annual athletic evaluations and a student athletic interest survey at least once every three years to ensure that equal athletic opportunities are provided for male and female students.

The Superintendent shall provide for the annual evaluation, periodic surveys, annual notices and complaint procedures as required by law to insure that there is in fact equal opportunity for all students in the District.

The Director of Special Services shall serve as the compliance officer for this policy.

The District shall publish, on their website and at least annually in print form, the following nondiscrimination statement:

The Woodland School District complies with all federal rules and regulations and does not discriminate on the basis of race, color, national origin, sex, sexual orientation including gender expression or identity, creed, religion, age, veteran or military status, disability, or the use of trained dog guides or animal service by a person with a disability and gives equal access to Boy Scouts and other designated youth groups. The District will also publish the nondiscrimination statement for the general public each spring with our Child Find Intervention Programs.

High Schools and Middle Schools shall publish, on their website and at least annually in print form, the following non-discrimination statement:
