HAZARD TREE EXTRACTION AGREEMENT

This agreement between Cowlitz-Skamania Fire District #7 with Yale School District, property owner and Lee Levanen Logging Co. LLC is for the purpose of extracting hazard trees on a portion of land at 11670 Lewis River Road Ariel. WA 98603.

Lee Levanen Logging Company agrees to extract hazard trees specified and marked by the landowner (on the north and east side of fire station) for fifty percent of saw logs and 100 percent of pulp logs delivered to the mill or other buyers selected by the logger.
