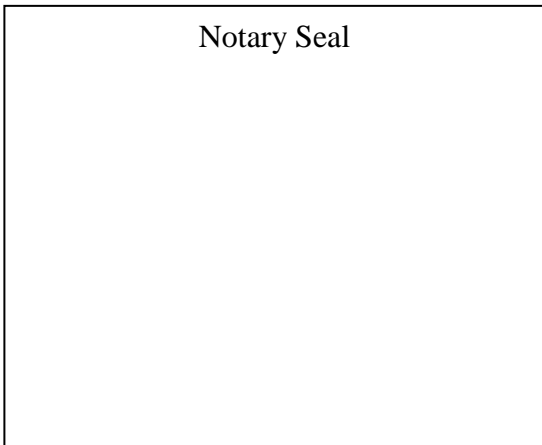

Dike Access Road Right of Way Dedication

Being a 5 foot wide strip of land located in the Southeast One-Quarter of Section 11, Township 5 North, Range 1 West, Willamette Meridian, and a portion of the Solomon Strong Donation Land Claim (D.L.C.), Willamette Meridian, Cowlitz County, Washington, said strip described as follows:

Commencing at the Northeast corner of said Southeast One-Quarter of Section 11;

Thence North $87^{\circ}46'41''$ West, 1316.06 feet to the Northwest Corner of said Southeast One-Quarter of Section 11;

Thence South $02^{\circ}16'37''$ West, along said west line of said Southeast One-Quarter of Section 11, 1301.80 feet to the **TRUE POINT OF BEGINNING**;

Thence South $87^{\circ}20'39''$ East, along a line 5.00 feet North of, when measured perpendicular to the North right of way line of Dike Access Road, 852.01 feet to the beginning of a tangent curve;

Thence continuing along a line 5.00 feet North of, when measured perpendicular to the North right of way line of Dike Access Road and the arc of a 608.00 foot radius curve to the right, through a central angle $16^{\circ}01'00''$ (the chord of which bears South $79^{\circ}20'09''$ East, 169.41 feet) an arc distance of 169.96 feet to a point of tangency;

Thence South $71^{\circ}19'40''$ East, continuing along a line 5.00 feet North of, when measured perpendicular to the North right of way line of Dike Access Road, 307.74 feet to a point on the Northwest line of that tract of land described in Auditors File Number 3351594, Cowlitz County Records;

Thence South $57^{\circ}20'49''$ West, along said Northwest line, 6.40 feet to the intersection of said line and the North right of way line of Dike Access Road;

Thence North $71^{\circ}19'40''$ West, along said North right of way line, 303.74 feet to a point of curvature;

Thence continuing along said North line and the arc of a 603.00 foot radius curve to the left, through a central angle of $16^{\circ}01'00''$ (the chord of which bears North $79^{\circ}20'09''$ West, 168.02 feet) an arc distance of 168.56 feet to a point of tangency;

Thence North $87^{\circ}20'39''$ West, continuing along said North line, 851.98 feet to the west line of said Southeast One-Quarter of Section 11;

Thence North $02^{\circ}16'37''$ East, along said west line; 5.00 feet to the **TRUE POINT OF BEGINNING**.

Contains 6,635 square feet or 0.152 acres, more or less.

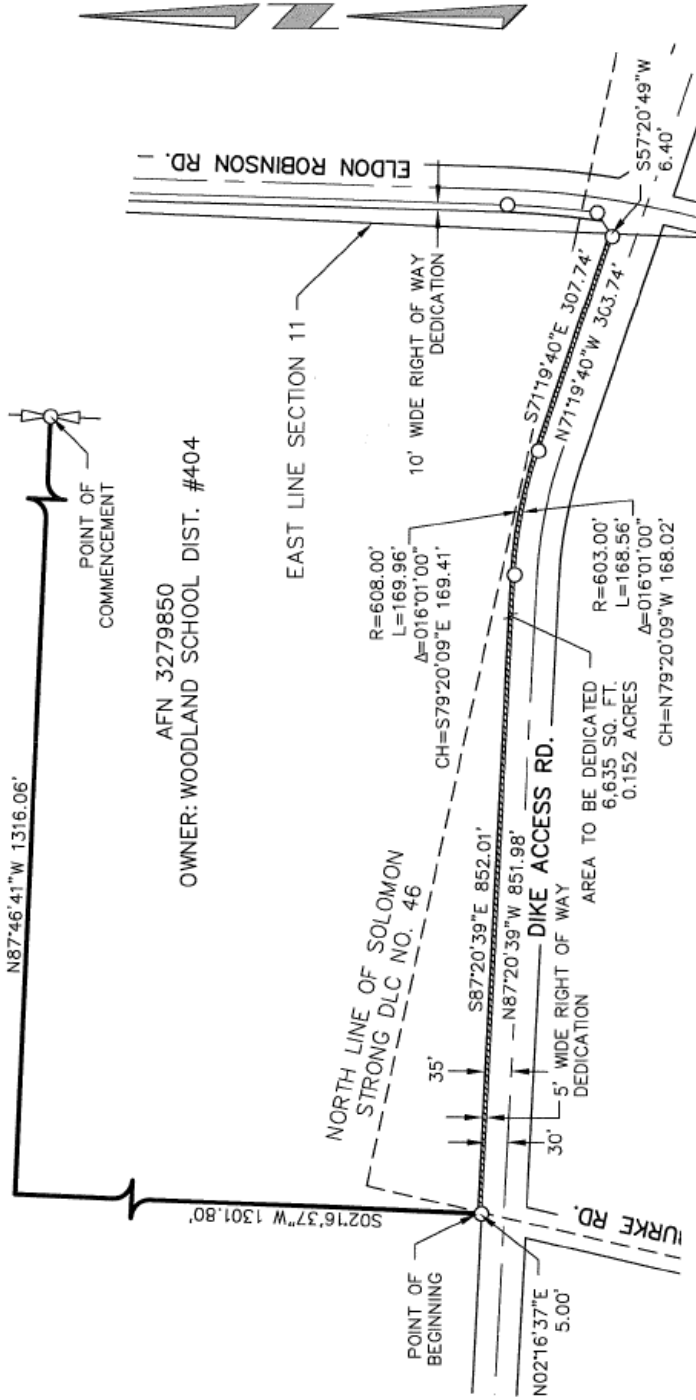
