Dear School Board Applicant:

Thank you for your interest regarding the Woodland School District school board vacancy. Appointment is through December 2013. If the appointee wishes to remain on the board, s/he must run for re-election to fill the unexpired term, The next election for this seat will be November 2013.

Director Area 5 represents a large geographic area on the eastern portion of the Woodland School District. The western boundary of the director district begins at the power line cut between the Lewis River Golf Course and Bryant Hill Road. The line proceeds north, following the power line until the line crosses Aho Carlson Creek Road. North of Aho Carlson Creek Road Kalama River Road is the western boundary until it crosses Oxbow Road. Oxbow becomes the western boundary until it crosses the unnamed creek just past Ferguson Road. Thenceforth north the creek becomes the boundary. In Clark County Director District 5 serves the area to the east of Northeast Happa Road. The borders to the north, east, and south correspond with the school district borders. A map of Director Area 5 follows this page.

A short application form is provided. It is important that you also submit a letter of interest identifying your background, as well as the skills, experiences and values you would bring to the school board if appointed

Applications are due in the district office by 4 pm, Tuesday, December 13<sup>th</sup>, 2011. Interviews for candidates with the entire school board are set for Monday, December 19<sup>th</sup>. The interview schedule will upon the number of candidates applying. Following interviews, the new board member will be appointed. The appointee will take the oath of office, and be seated during the regular meeting on January 9<sup>th</sup>, 2012.

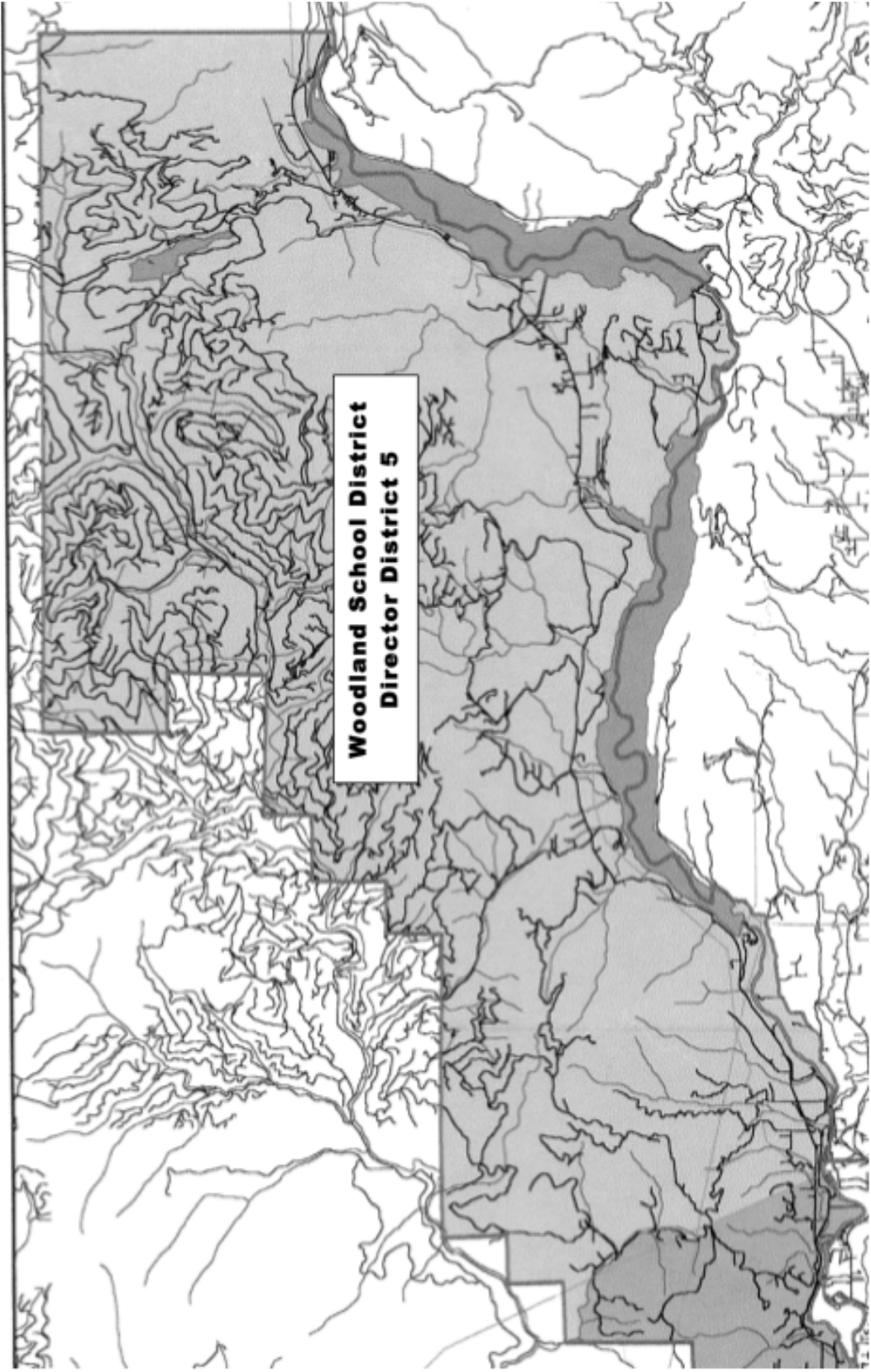
