Thank you for allowing NCC to comment on your concerns related to your HVAC control systems. Below are some key points that I hope will confirm that NCC is the best and most qualified contractor to maintain all of Woodland Public Schools facilities:

- The Service Contract Proposal has 312 hours dedicated to Mechanical work and are not directly related to the control systems in the District. 68 hours are listed as Flex time and can be used towards additional Mechanical services or Control system tasks. NCC has trained staff on BOTH the Network 8000 system as well as the Johnson Control System.
- 2. NCC has the most qualified Network 8000 Technicians in Oregon and Southwest Washington. Both Greg Fraser and Monty Grindy were previously the Senior Techs at CCI and actually trained other former staff members at CCI.
- 3. CCI has recently hired NCC to work at both Legacy Emanuel Hospital and Metro Headquarters as they were not staffed or qualified to perform the necessary service.

Woodland SD has a clear migration path to a more modern system while maintaining the existing investment in Network 8000.
