Two Key Decisions:

Term:

As short as one year, as long as four years

Total Amount:

Total amount levied NOT the tax rate

Assumptions for EP&O Levy Estimates:

- Tables that follow are <u>not</u> recommendations. They are provided as a foundation for discussion.
- Growth Rate Assumptions:
 - 5% per year
 - Same TAV Growth Rate used by other Cowlitz Districts
 - Average increase over last 8 years = 9.32%
 - Only one year, 2017, was below 5% (4.67%)
 - Cowlitz County Auditor does not anticipate a "Jump" in TAV like last year's in the foreseeable future.
 - Significant growth in housing is anticipated in the coming years. This has potential to have a measurable impact on TAV
